RULES & REGULATIONS

1. Date: Friday, April 22, 2022
2. Time: Friday 4 p.m. – 11 p.m.
3. Location: Mike Onka Memorial Building 11520 Putnam
4. Fee: 20'x20' space \$50.00.
5. For vendors selling food, a Jackson county health department temporary food permit is required, the form must be completed & returned to Jackson County Health Department, Environmental Health, 34900 E Old US 40 Hwy, P.O. Box 160, Grain Valley, MO 64029-0160 (816) 847-7073 Jackson county health department will do an inspection on Friday
6. **Food vending is allowed on Friday, April 22, 2022. Vendor's must maintain booth space until 11:00 pm Friday. RAIN OR SHINE EVENT**
7. VENDORS ARE ALLOWED TO SET-UP ANY TRAILERS ON THURSDAY NIGHT. Be aware there is no security until Friday morning. Food vendors may begin assembling areas by 8:00 am Friday. Areas must be set up and all service/supply vehicles removed from by 4:00 pm Friday.
8. Electrical power is provided. Extension cords will not be provided, please bring at least a 100 foot cord.
9. Canopies are welcomed and encouraged, but MUST NOT exceed booth space. Any shelters, tables or display racks provided by the vendor must be removed by the vendor no later than 2 p.m. Saturday. All vending area must be clean and clear of trash and debris by this time.
10. NO ALOCHOL SALES PERMITTED (drinks include but are not limited to: water, soft drinks, tea, lemonade, or the like are permitted).
11. Any shelters, tables or display racks provided by the participant must be removed no later than 2 p.m. Saturday. All electrical, fire and other codes applicable to this event must be adhered to. (Must provide fire extinguisher).
12. The committee reserves the right to deny any application at any time.
13. Smokin' In The Creek BBQ Contest or the City of Sugar Creek carries NO insurance for vendors and WILL NOT be liable for loss or damage from any cause.
14. BBQ samples and plates may be sold to the public.
15. Meat for selling may be brought to the contest pre-cooked. Please follow all Jackson County food guidelines for safe handling of food!
16. Vendors are responsible for collecting and reporting any sales tax.
